Function of Each Individual Assessment Period – ALL DELIVERIES IN THE UK AND OVERSEAS

January / February

- first assessment of all UK **Semester 1** modules (except postgraduate major projects which are submitted in late February and processed through the April meetings)
- first assessment of all UK **Trimester 1** modules (except postgraduate major projects which are submitted in late February and processed through the April meetings)
- re-assessment of the previous academic year's UK **Trimester 3** modules

February / March

- first assessment of all international **Semester 1** modules
- first assessment of all international **Trimester 1** modules
- re-assessment of the previous academic year's international **Trimester 3** modules

April

- first assessment of all UK **Semester 1 Extended** modules (HSCE in the UK only)
- first assessment of all (running out) UK **Session 1** modules (HSCE in the UK only)
- first assessment of UK **Semester 1** postgraduate major projects
- first assessment of UK **Trimester 1** postgraduate major projects

May

- re-assessment of all (running out) UK **Session 1** modules (due to NMC 12 week rule - HSCE in the UK only)
- assessment of UK **Trimester 2** modules from the LCA Business School (running out)

June

- first assessment of all UK **Semester 2** modules
- first assessment of all UK **Trimester 2** modules
- re-assessment of all UK **Semester 1 Extended** modules (HSCE in the UK only)
- re-assessment of all (running out) UK **Session 1** modules (not restricted by NMC 12 week rule - HSCE in the UK only)

July / August

- re-assessment of UK **Semester 1** modules
- re-assessment of UK **Trimester 1** modules
- re-assessment of UK **Semester 2** modules
- re-assessment of UK **Trimester 2** modules

- first assessment of all international **Semester 2** modules
- first assessment of all international **Trimester 2** modules
- first assessment of all UK **Semester 2 Extended** modules (HSCE in the UK only)

September

- first assessment of all UK **Trimester 3** modules (except postgraduate major projects which are submitted in late September and processed through the following academic year's November/December meetings)
- first assessment of all (running out) UK **Session 2** modules (HSCE in the UK only)

October

- re-assessment of all international **Semester 2** modules
- re-assessment of all international **Trimester 2** modules
- first assessment of all international **Trimester 3** modules

November / December

- first assessment of the previous academic year's UK **Trimester 3** postgraduate major projects
- re-assessment of the previous academic year's (running out) UK **Session 2** modules (HSCE in the UK only)
- re-assessment of all UK **Semester 2 Extended** modules (HSCE in the UK only)

NB: any module taught and assessed over a double period follows the structure for the latter period (eg: for a module delivered and assessed over Semesters 1 and 2, assessment is considered as a Semester 2 module outlined above)
